

**UNICEF EIGHTH INTERNATIONAL CHAMPIONSHIP**  
**Of Garda and Sabbia Valley – town of Gavardo**  
**Friday 02<sup>h</sup> – Saturday 03<sup>th</sup> – Sunday 04<sup>th</sup> aprile 2010**  
**REGULATION**

**ART.1 Organization**

Gavardo Football Association organises an International Championship named : Unicef 11<sup>h</sup> International Championship of Garda and Sabbia Valley, town of Gavardo, that will be held on 02-03-04 aprile 2010, as better specified in the Competition time table, at the Sports Centre of the Town Hall in 62, Viale O. Avanzi, Gavardo.

**ART.2 Participant range and age limit**

The championship is reserved to the category BEGINNERS B with a FIGC regular inscription or local foreign federation with its own society for the current season:

BEGINNERS B born from 01.01.1996 to the registered birthday of 12th year of age.

**ART.3 Loans**

Maximum 3 loans for each team are allowed, not interchangeable and valid for the entire championship, upon presentation of regular authorization released by the belonging society, which cannot be among the participant ones in the championship.

**ART.4 Players' list**

The participant societies must show the championship organisation, before its beginning, the list of the players they are going to use, up to a maximum of 18 people. Any modifications to the lists after presentation are forbidden. In the list presented to the referee before the competition, maximum eighteen (18) players will be indicated.

**ART.5 Changes**

Seven (7) changes are foreseen, independently of the role or at any moment of the competition.

**ART. 6 Participants societies**

Only the following professional teams will participate to this championship, except for the hosting team of Gavardo: GAVARDO – LUMEZZANE – MONTICHIARI - H.VERONA – CREMONESE - ALBINO LEFFE – BRESCIA - BOLOGNA (Italy).

ADO DEN HAAG(Holand) – BRONDBY (Danimarca) – TEAM TICINO (Svizzera) – LOKOMOTIV MOSCA (Russia)

**ART. 7 Championship formula**

The 12 teams will be divided into 4 groups, 3 teams each, by drawing and they will play as follows:  
FRIDAY 02 aprile 2010 9,30 a.m. – 9 p.m. “Qualifications”

Group A	1-2	loser 1.2 - 3	3-winner 1.2 - 3
Group B	4-5	loser 4.5 - 6	6-winner 4.5 - 6
Group C	7-8	loser 7.8 - 9	9-winner 7.8 - 9
Group D	10-11	loser 10.11 - 12	12-winner 10.11 - 12

The first teams of each group will have direct access to end quarters. The second and third teams of each group will play the eights quarters as follows:

Saturday 03 aprile 2010

Morning : 9 a.m. – 12 a.m. eighth quarters: (2A-3B) (2B-3A) (2C-3D) (2D-3C). The loser will play the finals from the 9<sup>th</sup>. to the 12<sup>th</sup>. place.

Afternoon: 3,30 p.m. official opening of the championship

Afternoon 5,00 p.m. end quarters (1C – AB) (1D – BA) (1A – CD) (1B – DC). The loser will play the finals from the 7<sup>th</sup>. to the 8<sup>th</sup>. place.

Sunday 04 aprile 2010

Morning: 8,30 a.m. – 12,30 a.m. (Semi Finals ) and (Finals from 12<sup>th</sup> to 9<sup>th</sup> place).

Afternoon : 2 p.m.- 6 p.m.: (Finals 7<sup>th</sup> – 8<sup>th</sup> place) (Finals 6<sup>th</sup>. and 5<sup>th</sup>. place) (Finals 4<sup>th</sup> – 3<sup>rd</sup> place) (Finals 2<sup>nd</sup> – 1<sup>st</sup> place)

#### **ART. 8 Classified results**

Classifications will be held according to the following principles:

- 3 points for the win
- 1 point for the draw or defeat at penalty-kicks
- 2 points for the win at penalty-kicks

In case of point - draw the following rules will be valid:

- direct matches outcome
- difference of goals on the total of the matches done
- difference of goals on the total of the matches you dispute in the turn
- bigger number of goals scored on the total of the matches you dispute in the turn
- draw

#### **ART. 9 Match times**

Since the time table foresees a fast course of the championship (more matches in the same day and in close days for the teams) competitions will be held as follows: on Friday triangular of 30 minutes non stop. On Saturday end of quarters and semi finals, two matches 20 minutes + 20 minutes. On Sunday, finals, from 3<sup>th</sup> to 12<sup>th</sup> place, 20 + 20 minutes, grand final 20 + 20 minutes.

#### **ART. 10 Penalty kicks**

(foreseen in finals, eights-finals, quarter-finals and semi-finals)

In case of draw at the end of regulation times, penalty kicks, according to the rules stated in article 7 of the play rules and official decisions, will be taken.

#### **ART. 12 Referees**

Matches will be leaded by FIGC AIA referees.

#### **ART. 13 Championship Committee**

The Championship Committee will be responsible for any debate, complaint, claim or any circumstance not foreseen.

Following persons will be Members of the Committee:

- Stefano Susio AC Gavardo Vice President

- Vacinaletti Livio AC Gavardo Member
- Susio Stefano AC Gavardo Member
- Leonello Cavagnini AC Gavardo Torneo Secretary

**The committee will not accept protests or complaints made by referees**

Any player guilty for foul play, will be handed over to its national federation which will choose how to proceed. Each member of the participant delegation who is acting in an unsporting way during the championship will be handed over by written form from the championship committee to the national or international federation which will choose how to proceed.

**ART. 14 Championship Discipline**

The regular Sports Judge or the reference committee Deputy Judge are entrusted with the championship discipline.

**ART. 15 Sanction system**

It is foreseen according the following standards:

the player who has been expelled during a match will not be able to take part in the following competition, unless major sanctions have been inflicted by the Sports Judge.

The player who during the championship is cautioned for the second time will be disqualified from a match upon the Sports Judge declaratory judgment.

**ART. 16 Complaints**

Any complaints must be lodged within 30 minutes from the end of the match, together with a fee of € 50,00 (fifty Euros). A copy of the complaint must be delivered to the counterpart within the same time limit of 30 minutes.

**ART. 17 Insurance**

Each participant society has to insure all his players. The championship's organization is responsible for the regularity of the insurance.

**ART. 18 I.F.A.B**

The Championship will be held according to the rules of the International Football Association Board (I.F.A.B.)

**ART. 19 Educational Meetings**

The organization committee during the championship will organize in co-operation with the Settore Giovanile e Scolastico al committee a technical educational meeting addressed to technical people, managers, parents and players.

**ART. 20 General Rules**

For those cases which are not foreseen in this regulation, the federal regulation dispositions are valid, if compatible, and those which are stated on the N° 1 Official Communicate of the Young Section and Football School concerning the current season.
